Positions

The successful candidate will regularly teach graduate and undergraduate level courses in civil engineering; advise students; serve on academic committees; and contribute to the Department, College and University governance. Undergraduate teaching expectations will involve subject areas beyond the graduate level specialization in addition to developing new courses in promising areas of geotechnical engineering or transportation engineering. Faculty members are expected to be team players willing to contribute to the mission of the Civil Engineering Program, College of Engineering and Computer Science and the University. Positive tenure and promotion decisions require excellent teaching, research, refereed publications, and active participation in the university and the profession.

Qualifications

Applicants must have the following attributes:

- An earned Ph.D. in civil engineering or a closely related field. Evidence of completion of doctoral degree must be available by the start date in order to be hired into the tenure track position but those who are yet to receive the degree may be hired on a visiting basis.
- Undergraduate degree in civil engineering.
- Record of publications in his or her area of expertise.
- Ability and willingness to support undergraduate and graduate teaching needs of the department.
- Ability and willingness to interact effectively with a culturally diverse group of students and colleagues.
- An earned professional engineer license or eligibility and willingness to acquire it.

The position will be at the rank of Assistant Professor (tenure-track). Salary is competitive and commensurate with qualifications and experience.
